

**THE SINGING ANGELS PERFORMING CHORUS
RULES OF CONDUCT & DISCIPLINE PLAN
2009-2010 SEASON**

Angel and Family: Please read, and acknowledge by signing below, that you understand and intend to comply with the following Rules of Conduct & Discipline Code.

- 1. I understand that I am expected to always be on my best behavior at all Angel rehearsals and concerts.**
- 2. I have read and understand the 2009-2010 Rules and Regulations Handbook.**
- 3. I understand that if I misbehave (as described in the ANGEL CONDUCT and DISCIPLINE sections of the Rules and Regulations Handbook) DURING A REHEARSAL, the following Discipline Plan will be implemented:**
 - a. I will receive at least one verbal warning, depending on the problem.**
 - b. If I continue to misbehave I will be asked to leave rehearsal and I will be escorted to the Office, where I will be supervised until I can meet with a Staff member. I will meet with the Staff member and the incident will be noted on a Behavior Form. I will receive a copy of the Form and a copy will be placed in my permanent file. Depending on the incident, including factors such as the severity of my misbehavior or the frequency or ongoing nature of my misbehavior, Staff may also call my Family and/or schedule a Discipline Meeting.**
 - c. A Discipline Meeting is a meeting of Staff, Board member, Family and Angel. The purpose of the Discipline Meeting is to allow all parties to discuss the Angel's behavior/conduct and then develop a Plan that will allow the Angel to benefit from the Singing Angels' program. Punishment may be a part of the Discipline Plan, and may include suspension from rehearsals or concerts.**
- 4. I understand that if I misbehave DURING A CONCERT (as described in the Rules and Regulations Handbook), the following Discipline Plan will be implemented:**

Staff will remove me from the performance as soon as possible and I will remain with Staff for the remainder of the performance, and I will receive an excused absence. Staff will complete a Behavior Form. I will receive a copy of the Form, and a copy will be placed in my permanent file. Staff will call my Family and a Discipline Meeting, as described in 3 c may be scheduled.
- 5. I understand that my Family and I may schedule a meeting with Staff and Board members at anytime during the Program Season to discuss my behavior, as well as the expectations of The Singing Angels. I also understand that I may inform Staff of any special circumstances that would be a challenge for me at rehearsals or concerts.**
